

NOTICE OF PUBLIC HEARINGS

The Shenandoah County Board of Supervisors will hold a public hearing on **Tuesday, October 13, 2020, at 4:00 p.m.** in the Board Meeting Room of the County Government Center, 600 North Main Street, Woodstock, Virginia, during which the Board will receive public comments concerning the following:

An ordinance amending the Fiscal Year 2020-2021 Budget, as summarized in the table below, and appropriating the funds budgeted for expenditure. The Board intends to propose the ordinance for passage. The total proposed FY 2020-2021 General Fund Budget is \$86,539,567. The ordinance does not change any tax rates, and all other Fiscal Year 2020-2021 budgeted revenues and expenditures remain unchanged.
