Burn Permit Application

Burn Permit Application for the disposal of debris waste resulting from property maintenance from the development or modification of roads and highways, parking areas, railroad tracks, pipelines, power and communication lines.

The following conditions shall be met for the purpose of a burning operation

- I. If any power lines are near the burn site, the respective Power Company must be contacted for approval of the burn. Written approval must be submitted along with the burn application.
- II. If burning is going to take place less than 500 feet away from an occupied structure you must have permission from the occupant. Written permission from the occupant must be submitted along with the burn application.
- III. All reasonable effort shall be made to minimize the amount of material burned, with the number and size of debris piles.
- IV. The material to be burned shall consist of brush, stumps, and similar debris waste and shall not include demolition material.
- V. The burning shall be conducted at the greatest distance practical from highways and airfields.
- VI. The burning shall be attended at all times and conducted to ensure the best possible combustion with a minimum of smoke being produced.
- VII. The burning shall not be allowed to smolder beyond the minimum period of time necessary for the destruction of the materials.
- VIII. The burning shall be conducted only when the prevailing winds are away from any city, town, or built up area.
- IX. The burning shall comply with Virginia Department of Forestry Laws and Regulations. Laws and Regulations can be obtained from the Shenandoah County Department of Fire and Rescue or Department of Forestry at 540-459-3151 or www.state.vipnet.org/dof/fire/firelaw.
- X. The application, with required documents, then needs to be submitted to the Fire Prevention Office for review.



- XI. If all provisions are complied with a permit will then be issued to the applicant.

Violations and Penalties for non Compliance

* Any violation of the Code of Shenandoah County chapter 80 is punishable as a Class 1 misdemeanor. Each separate incident may be considered a new violation.

Applicant must have a drawing of directions to the site and the exact location on the property where the material is to be burned.
